

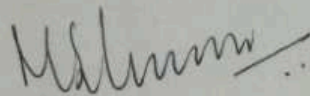
The meeting of College Development Committee was held on 02nd November 2018 at 11.30 am. The following members were present.

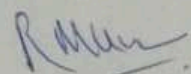

9. Sir Dr. M. S.Gosavi guided about C' Component subjects and about revision of syllabus.



The decision was accepted unanimously.

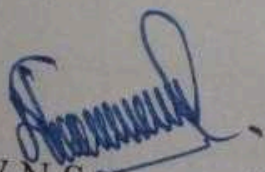
8. To sanction the leaves of the staff, if any.

The list of the staff who have availed the leaves was presented in the meeting. It was resolved that the leaves as per rules be sanctioned.

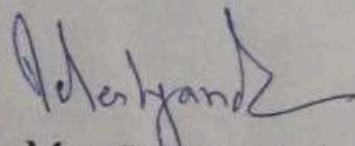
9. Following items were discussed with the permission of chair
